
Q1 Which best describes the student composition of your school?



Q2 How many students are in your 2016-2017 senior class?



Q3 Where is your school located?







Q7 Which of the following descriptions accurately describes the standardized testing practices of your students? Please check all that apply.







Q10 Which of the following best captures your school's approach to AP?





Q12 Which of the following best describes the administration and oversight of standardized testing at your school?



Q16 How many counselors report to the Director(s) of College Counseling?



Q20 Which of the following best describes the education earned by the Director(s) of College Counseling? Please check all that apply.



Q21 How often does the Director(s) of College Counseling report to the Board of Trustees?





Q23 Which best describes the average FTE (Full Time Equivalent) caseload in your office (i.e. # of seniors divided by the number of FTE college counselors)?




Q24 Does the Director of College Counseling have a reduced caseload?



Q28 Does the compensation for your other counselors include housing?





Q33 Does your school use its own Secondary School Report?



Q34 Do you evaluate the rigor of a student's curriculum, either on your own SSR or on the Common Application?









Q40 Which best describes the matriculation information that your school provides publicly?




